The program provides a range of legal services, including cases on domestic violence, child support, custody, paternity, property registration and titling. During the past fiscal year, the program provided 1771 legal services to 799 women.

Community Advocates Program - trains women to be leaders, women's rights educators, and peer mentors. Advocates assist WJI with workshop facilitation, participant recruitment, and home visits to women in need of legal aid. In 2024, WJI has trained 82 Community Advocates.
